## 4. FIRST AID MEASURES

### First aid measures

<b>General advice</b>	Immediate medical attention is required.
<b>Eye contact</b>	Keep eye wide open while rinsing. Immediate medical attention is required. Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Do not rub affected area.
<b>Skin Contact</b>	Immediate medical attention is required. Remove contaminated clothing and shoes. Wash off immediately with plenty of water for at least 15 minutes. Wash contaminated clothing before reuse.
<b>Inhalation</b>	Remove to fresh air. Call a physician or poison control center immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen.
<b>Ingestion</b>	Call a physician or poison control center immediately. Do NOT induce vomiting. Clean mouth with water and drink afterwards plenty of water. Remove from exposure, lie down. Never give anything by mouth to an unconscious person.

### **Most important symptoms and effects, both acute and delayed**

**Symptoms** The product causes burns of eyes, skin and mucous membranes.

### **Indication of any immediate medical attention and special treatment needed**

**Note to physicians** Product is a corrosive material. Use of gastric lavage or emesis is contraindicated. Possible perforation of stomach or esophagus should be investigated. Do not give chemical antidotes. Asphyxia from glottal edema may occur. Marked decrease in blood pressure may occur with moist rales, frothy sputum, and high pulse pressure. Treat symptomatically.

## 5. FIRE-FIGHTING MEASURES

### **Suitable Extinguishing Media**

Use extinguishing measures that are appropriate to local circumstances and the surrounding environment.

**Unsuitable Extinguishing Media** Caution: Use of water spray when fighting fire may be inefficient.

### **Specific hazards arising from the chemical**

The product causes burns of eyes, skin and mucous membranes. Thermal decomposition can lead to release of irritating and toxic gases and vapors. In the event of fire and/or explosion do not breathe fumes.

#### Appropriate engineering controls
